# FINANCE COMMITTEE:

Stewart welcomed Charmaine Gahan to the Finance Committee and also encourages new members to join.

Sarah Smith indicated the receipts for Electric, Harbor and Wharf are strong. The expenses associated with the water projects and the fuel farm project will be accounted for in FY20. The overall budget will be over about \$10,000 - \$15,000. The loan for the water projects will be used in FY21 to pay for expenses associated with both projects.

Regarding FY 2021, Town Counsel is over budget, the overall budget looks good at this time. Sarah will speak with Michael Milanoski regarding her questions about the Financial Management Policy.

The new budget process for FY 2022 will begin in early 2021. Department Heads will be asked to anticipate any capital expenses.

Sarah reported that QuickBooks is now web hosted and the service is much improved.

#### **BOARD OF HEALTH:**

#### PLANNING BOARD:

An Approval not Required subdivision plan was submitted by Vineyard Land Surveying on behalf of The DiMare Family Living Trust for property located at 5A Bayberry Hill Road, Cuttyhunk, MA 02713. The ANR Plan is for the division of lot 66, creating two lots. There is a minimum of 7,500 SF per lot with 60' of frontage. Once approved it will be filed with Land Court.
