# GOSNOLD BOARD OF SELECTMEN August 29, 2022

#### **BOARD OF SELECTMEN:**

A motion was made to approve the USDA loan resolution in the amount of \$1,648,000.00; converting the short-term loan to the long-term loan and authorizing the Board of Selectmen to sign the USDA documents. Duly seconded. So moved. Roll Call: Gail Blout – here, Sarah Berry – here, Stewart Young – here. Unanimous vote.

A motion was made to approve and sign the warrant for the September 6, 2022 State Primary. Duly seconded. So moved. Roll Call: Sarah Berry – here, Gail Blout – here, Stewart Young – here. Unanimous vote.

There were two letters complaining about late night party noise at the main dock/ferry dock.

Warrants were reviewed and signed.

# Water Project:

Leo reported that EP submitted change order #2; extending substantial work completion to September 15. Work will begin at the pumphouse after Labor Day and paving will begin on September 12 and continue until the end of the month.

A motion was made to approve the change order from EP extending the substantial completion of work to 9/15, with final payments/project completion still due by 12/31/2022. Duly seconded. So moved. Roll Call: Sarah Berry – here, Gail Blout – here, Stewart Young – here. Unanimous vote.

David Warr would like to see the filter socks replaced where they have eroded.

Leo explained that a pay requisition is due to Dig it in the amount of \$208,998.09. A motion was made to approve the pay requisition for Dig It. Duly seconded. So moved. Roll Call: Sarah Berry – here, Gail Blout – here, Stewart Young – here. Unanimous vote.

There were questions about paving which will take about 6 days.

Boone Porter would like to make sure that when the paving is done on Broadway that the water is diverted from going down Allen House Drive as the town should be maintaining the gutters that have been in place for years.

## **GREEN COMMUNITY:**

The energy audit for town buildings has been completed; they are now asking for the power louse electrical usage.

#### **FUEL FARM:**

Gail reported that the site has been filled in and all contaminated soil has been removed. All of the above ground pipes have been removed as well.

Michael Milanoski reported that he and Gail met with Foth; the bid package for the new fuel farm will go out in September with bids due in mid-October. Mobilization will begin in mid-November and the concrete pads will be installed by year's end. The majority of the project will be completed by April 2023.

Michael reported that Chilmark has a concessionaire for their fuel station which is managed by Parks and Recreation. Michael suggested the Harbor Management Committee manage the new fuel farm project and make recommendations to the Board of Selectmen. Leo agreed that this makes sense as this is a large waterfront project for the Town of Gosnold.

## CEMETERY:

Gail reported that the public response to cemetery fencing favored some kind of a wooden fence over granite; either split rail or straight wooden posts. Split rail is a bit cheaper but will take longer to install. The Board of Selectmen decided to go with split rail and Gail will finalize costs for the installation.

## **POWERHOUSE:**

Wayne reported that we lost a couple of inverters from the lightning storm and 2 transformers as well. Sarah will call the insurance company regarding a claim.

Matt from DLM is doing an assessment of the powerhouse and grid. This will also gauge how additional electrical load the infrastructure can handle.

## HARBOR MANAGEMENT COMMITTEE:

Harbor Management Committee will be meeting on 9/20 @ 10:30 and will be reviewing the plans for the new public bathroom facility.

## SCHOOL:

The School Committee is working on a building usage and fee policy.

# SHELLFISH:

The harbor will be open for shell fishing October 1.
