### COMMONWEALTH OF MASSACHUSETTS TOWN OF GOSNOLD WARRANT ANNUAL TOWN MEETING May 23. 2022

County of Dukes County, ss.

To either of the Constables of the Town of Gosnold: GREETINGS

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Gosnold qualified to vote in town affairs and elections to meet at the Avalon in said Gosnold on Monday, May 23, 2022 at 10:30 in the forenoon to act on the following articles:

Article 1: To choose a moderator to preside at said meeting. *Unanimous vote to elect Leo Roy moderator.* 

Article 2: To hear the report of the Town Officers and act th

Article 2: To hear the report of the Town Officers and act thereon. *Sarah Berry read Stewart Young's report.* 

Article 3: To see if the Town will vote to reduce the size of the School Board from 4 members to 3 members, or take any other action

thereon.

*Unanimous vote to postpone the article.* 

Article 4: To elect the following officers for the ensuing terms and set salaries for the same in the below amounts, or such other amounts as the Town determines.

a. One Selectman, Board of Health member for 3 years. Salary \$7,179.00

Unanimous vote to elect Stewart Young.

b. One School Committee members for 3 years. Salary \$125.00

Unanimous vote to elect Judith Archer.

One Public Library Trustee for 3 years.
 No Salary.
 Unanimous vote to elect Kris Lombard.

d. Two Harbor Committee Members for 3 years. No Salary.

Unanimous vote to elect Lexi Lynch and Seth Garfield.

Article 5: To see if the Town will vote to authorize the Treasurer, with approval of the Board of Selectmen, to borrow money from time to time in anticipation of the revenues for the financial year beginning July 1, 2022, in accordance with the Provisions of General Laws chapter 44, section 4.

Article 6: To see if the Town will vote to authorize the Treasurer to enter into compensating balance agreements for the financial year beginning July 1, 2022 in accordance with Provisions of General Law's chapter 44, section 53F.

Article 7: To see if the Town will vote to appropriate a sum of money to defray town charges and expenses for the fiscal year ending June 30, 2023.

Article 8: To see if the Town will vote to appropriate a sum of money in anticipation of reimbursement of the Commonwealth's share of the cost of work under Massachusetts General Laws, chapter 90, section 34.

Article 9: To see if the Town will vote to appropriate a sum of money for expenses of the Harbor Management Committee.

Article 10: To see if the Town will vote to appropriate a sum of money for the Water Enterprise Fund.

Article 11: To see if the Town will vote to appropriate an amount of money for the State indemnity for pest and disease control in accordance with the Provisions of General Laws, chapter 132, section 14.

Article 12: To see if the Town will vote to appropriate and transfer a sum of money into the Stabilization fund, or take any other action thereon

Unanimous vote to accept Articles 5-12 as written.

Article 13: To see if the Town will approve a petition by the Board of Selectmen to the General Court to enact special legislation authorizing the Town of Gosnold to change the name of the Board of Selectmen to Selectboard, or take any other action thereon.

Unanimous vote to accept Article 13 as written.

Article 14: To see if the Town will vote to appropriate the sum of

\$100,000 for the water/roadways project from Chapter 90

funds.

Unanimous vote to accept Article 14 as written.

Article 15: To see if the Town will vote to appropriate the sum of \$85,000

as its matching share of a grant of \$425,000 from the Seaport Economic Council for the construction of improvements to the Visitors Center the former Coast Guard station, or take any

other action thereon.

Unanimous vote to accept Article 15 as written.

Article 16: To see if the Town will vote to appropriate \$42,400 as its

matching share of a grant of \$212,000 from the Office of Coastal Zone Management for the design of a municipal fuel

facility, or take any action there on.

A motion was made to amend the appropriation to \$53,000.

Unanimous vote to accept Article 16 as amended.

Article 17: To see if the Town will vote to appropriate a sum of \$37,400

or a lesser sum as its matching share of a grant of \$106,000 from the United States Department of Agriculture for Solid

Waste and Powerhouse Equipment.

Unanimous vote to accept Article 17 as written.

Article 18: To see if the Town will vote to authorize the selectmen to

enter into a lease of the Fuel Farm and the Fuel Dock for up to 10 years, with an option for an extension of ten years, or such term as the selectmen approve, or take any other action

thereon.

Unanimous vote to accept Article 18 as written.

And you are hereby directed to serve this Warrant by posting an attested copy of the same in the Post Office Building on Cuttyhunk Island and in the Farm House Building on Hadley Harbor on Naushon Island not less than seven days before the day appointed for said meeting.

### **GREETINGS:**

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Gosnold qualified to vote in town affairs and elections to meet in the Town Hall in said Gosnold on Monday, January 23, 2023 at 11:00 in the forenoon to act on the following articles:

Article 1: To choose a moderator to preside at said meeting.

Unanimous vote to elect Lisa Wright as moderator.

Article 2: To see if the town will vote to appropriate the sum of \$700,000 or any other sum, for the so-called Fuel Farm Project, consisting of the construction of storage tanks for diesel and gasoline and related facilities, and for the reconstruction of the public toilet facilities, and to authorize the Town to raise such sum by borrowing up to \$500,000 and transferring \$200,000 of available funds from the Town's Harbor Special Projects fund, or by any other means, or take any other action thereon.

Unanimous vote to accept Article 2 as written.

Article 3: To see if the town will vote to raise and appropriate up to \$20,000 for the purpose of making various repairs to the schoolhouse building, or take any other action thereon.

Unanimous vote to accept Article 3 as written.

Article 4: To see if the Town will vote to enact a General Bylaw entitled "Stretch Energy Code" for the purpose of regulating the design and construction of buildings for the effective use of energy, pursuant to Appendix 115.AA of the Massachusetts Building Code, 780 CMR, the Stretch Energy Code, including future editions, amendments or modifications thereto, a copy of which is on file with the Town Clerk, or take any other action thereon.

### CULTURAL COUNCIL

The Town's Cultural Council receives federal (National Endowment for the Arts) and state (Massachusetts Cultural Council - MCC) pass through funds. During the summer of 2022 The Council supported the following:

-The 7th Annual Cuttyhunk Plein Air Festival in June was fortunate to be back in person after two years of being virtual. Artists once again travelled by ferry to spend a day capturing the many sites of Cuttyhunk on their individual canvases. Culminating at the end of the day with a show on Seth and Dorothy Garfield's yard for islanders to peruse the freshly finished pieces of artwork, and buy if they so choose.

- The Annual July Avalon Inn Family Lawn Concert, featured "On Island Time," a six-piece band based out of Massachusetts that explored the sounds of New England jazz.

- A Book reading, *Six Walks* by author Ben Shattuck who is the Director of the Annual Cuttyhunk Writer's Residency.
- A Poetry Workshop and reading with Cammy Thomas. A two-day island poetry workshop culminating with a poetry reading from poet and instructor, Cammy, as well as attendees were invited to share their own poems.
- -The 2nd Annual Cuttyhunk Island Variety Show hosted at the Wilder House at Four Corners. Cultural Council Committee member, Mike Frazel organized another outstanding outdoor talent show complete with a stage, sound, and lighting. Performers entertained the community; islanders, visitors, boaters, for close to two hours on a beautiful summer evening. In true Cuttyhunk fashion all ages were encouraged to participate whether they were 6 or 66! People sat in lawn chairs, on blankets, in their golf carts and stood in the road as this show was not to be missed. It has become an annual summer event that all look forward to.
- Plein Air Painting Workshops in July and August with Tammy Zimbone. The perennial favorite watercolor classes.
- The Chris James Trio band returned for their second performance at the Fish Dock on Labor Day Weekend. They played and played while most of the audience danced and danced. A high energy band that was a wonderful way to welcome September and most likely will return again in 2023!

Please note: According to the Massachusetts Cultural Council's protocol, we adhere to the prescribed grant-making process. This includes compliance with a conflict of interest policy, and a required formal online application for all artists and 501 (c)3 organizations seeking funding. As a group we work closely with our Massachusetts Cultural Council liaison, Timothea Pham, who provides excellent advice as well as being a great source of information and support to the Council.

### **CUTTYHUNK STEAM ACADEMY**

The Cuttyhunk STEAM Academy relaunched in the fall of 2021 under the auspices of the Gosnold Public Schools and entered into the new year with a new Board of Directors who began pursuing 501c3 non-profit status through the state and federal agencies.

In the spring of 2022, the Cuttyhunk STEAM Academy hosted several day programs for students from New Bedford, Mattapoisett, and Martha's Vineyard. The New Bedford school group was a joint collaboration between Buzzards Bay Coalition and SeaLab and afforded over two hundred 5th grade students an exciting opportunity to explore and learn about Cuttyhunk. This partnership also included a day trip visit by educators and a special summer trip for 9th grade students. During April vacation week, the STEAM Academy hosted a program about climate change that engaged several visiting island children throughout the week in an outdoor classroom experience.

By July 2022, the Cuttyhunk STEAM Academy had attained its non-profit status at the state level and officially became Cuttyhunk STEAM Academy, Inc. Full oversight transitioned to the Board of Directors. This transition was only the first step in establishing the organization and complying with the various state and federal regulations while applying for federal non-profit status.

With staff hired, the academy hosted its first official overnight program with much success early September. The event would not have been as successful without the involvement of several island residents and volunteers: Shelly & Jay Merriam, Seth Garfield and Charmaine Gahan, Tammy Zimbone, Elsa Couvillion, and Chandon Barry. Additionally, the academy wouldn't be what it is without the wrap-around support from Pete's Place Rentals and the Cuttyhunk Ferry Co, Inc.

This spring, over ten day programs and a couple of multi-day/night events are scheduled with new and returning school groups. As the Cuttyhunk STEAM Academy further establishes itself, the frequency of programs expects to grow as awareness and presence is seen and experienced. This summer, the academy is also sponsoring several activities and fundraisers including a Plant Sale Memorial Day Weekend, the Get STEAMED! Challenge, STEAM Pop-ups, children's weekly programs, a Spaghetti Supper the night before the town fireworks, and a Shoe Drive later this year. The STEAM Academy staff and board looks forward to connecting with you and sharing all that is happening.

The Cuttyhunk STEAM Academy began with a vision more than four years ago

to showcase and retain the vibrancy of the island through the off season in an innovative manner. The Town of Gosnold and the Gosnold School Committee have supported this vision and its potential. It is also critically important that the Cuttyhunk STEAM Academy recognize and celebrate its many donors and supporters. The COVID-19 pandemic severely interrupted and shelved the plans that were in process, but you understand the value the academy can bring to others and to the island community - we thank you for your continued support and contributions.

In closing, we most especially thank you, the island residents, who have graciously welcomed the students and teachers, and volunteered your time to share the wonder of the island with them. The Cuttyhunk STEAM Academy could not happen without the assistance and commitment of the village that is Cuttyhunk Island. With your expertise and participation, the Cuttyhunk STEAM Academy looks forward to establishing the program as a cutting edge, creative model for all

# GOSNOLD COMMUNITY FUND GOSNOLD COMMUNITY SCHOLARSHIP FUND

This Annual Report is also an appeal for your donations to the Gosnold Community Fund and to the Gosnold Scholarship Fund.

Many years ago, when the roof structure of the Cuttyhunk church was about to collapse, The Gosnold Community Fund (GCF) awarded a grant to the church for emergency modifications until restoration could occur. Someone asked if the Selectmen had approved the grant, as it hinted at a violation of "church and state".

The Gosnold Community Fund, and its sister, the Gosnold Community Scholarship Fund are not regulated by the Selectboard. These privately donated funds are under the guidelines of the original investors/founders who specified that the fund be used for proposals that "best serve the needs of the community." To some, the needs of the community could be interpreted as too dangerously broad and encompassing; however, I believe the founders fully intended this.

While not fully funding a project, The GCF has contributed toward all sorts of needs. Grants towards stone wall repairs; toward a golf cart for the doctor at our free Summer Clinic; from an emergency at the Electric Dept. to building the new playground; toward roofing of The Avalon, and a new septic system for Yacht Club; toward the new library and toward acquisition of land for conservation. Once, for a pickleball court. And in 2022, towards the new cemetery fence.

All grants comply with the founders' guidelines: "best serve the needs of the community including education, technical training, health, recreation, historic preservation, and the environment." Very broad, indeed. And far-thinking.

Except for Scholarships, individuals cannot receive grants. Recipients must be non-profit organizations. Scholarship applications are available at Town Hall, or on line at <a href="https://cfsema.fcsuite.com/erp/donate/create/fund?funit\_id=1166">https://cfsema.fcsuite.com/erp/donate/create/fund?funit\_id=1166</a> The annual deadline for Scholarship applications is June 30th of the current year. On the other hand, proposals for grants can be submitted any time by anyone representing a non-profit. Contact any committee member below.

We encourage your proposals, but we DEPEND on your contributions. Your generosity keeps the GCF growing. The donors are the same, year after year. It reminds me of the saying: "if you want a helping hand, look to the end of your own arm". How wonderful that community members --residents or renters;

voters or visitors--see a need from which we all can benefit. The GCF is the manifestation of a community that cares about its members, that seeks to improve the quality of life, but that regulates and adheres to the founding principles.

As of December 2022, the Gosnold Community Fund balance was \$726,317.24, as principal. The Grantmaking Fund balance was \$21,546.41, the interest, which we can use. The Gosnold Scholarship Fund balance was \$16,434.33. All are managed by the Southcoast Community Foundation with care and expertise.

### GOSNOLD CONSERVATION COMMISSION

Another busy and productive year for the Gosnold Conservation Commission (GCC) in 2022. There were numerous issues to deal with, including consequential submissions and hearings related to major projects on Cuttyhunk Island. The activities included the following:

A Notice of Intent (NOI) for underground utility installation was filed by the Cuttyhunk 2008 Nominee Trust regarding an underground utility installation on property owned by the Trust. The project had already been completed. After vigorous discussions regarding the situation, the GCC voted to issue and Order of Conditions (OOC) for the project, reserving the right to issue a fine against the contractor

As part of the family's move to place two Conservation Restrictions (CR) over the majority of their land on the West End, the GCC voted to authorize the Commission's Chair to sign the municipal certification for Gosnold CR-9 and Gosnold CR-10. This action meets the requirement that the Conservation Commission certify that the lands have conservation value. This conservation value is no protected by placement of the CRs.

Approved a request from John Rockwell to replace two pilings which are in the basin and are license

Approved a request from the Scott family to replace pilings and decking on their dock at Copicut Neck. A Chapter 91 license should be on file.

Welcomed Michelle Carvalho who informed the GCC about a STEAM Academy Climate Change Unit that has been prepared to include in the curriculum. The Commission thanked Michell for the information, concluding that the GCC need to take no action on the proposal.

A Notice of Intent filed by the Town was dealt with at a hearing on April 15, 2023. The proposal was to restore fuel storage and service to the island, improve the solid waste operation as well as adda public bathroom to the site. Fuel would be stored in two ConVault 6,000 gallon above ground storage tank, the solid waste containers would be relocated on a new concrete pad system, and a stan-alone vault public restroom would be installed. Following a thorough discussion with the proponents by the member s of the Commission, amotion was made to accept the project as presented with a request that the engineers determine some type of protection for movement of the solid waste containers to the fuel tanks and that the plan for the protection of the fuel tanks be submitted back to the GCC for review. The vote in favor of the motion was unanimous.

The GCC approved the plan submitted by Ralph Packer to complete the cleanup of the Fuel Farm site. The plan was created by LSPs (Licensed Site Professionals) representing bot the Town and Mr. Packer. This was required by the GC before any work could begin on the tank replacement project.

A Notice of Intent was filed by the Naushon Trust for the renovation of a Community Stable. The Commission heard from the engineer for the project and questions from the members were answered by the proponents. Following the presentation by the engineer and the discussion that ensued, a motion was made to approve the Naushon Island Community Stale project as presented. There as a unanimous vote in favor of the project.

Receive a Request for Determination of Applicability (RDA) from the Naushon Trust for repair project on an existing Stone Pier including a wall and walkway to the pier. Reid Silva of Vineyard Land Surveyors presented the plan of the proposed work which would be consistent with the existing Chapter 91 license. Following questions and discussion among the members and with the proponents a motion was made that the GCC authorize the work to proceed as presented and prepare a letter informing the Naushon Trust, Inc. that work could proceed with no further review. Three members voted in favor. There was one abstention.

Received and RDA from the Town regarding Coast Guard Boathouse improvements. Selectboard member Gail Blout presented the project explaining that most of the work was interior construction, except for replacing the roof. She explained that the Massachusetts Historical Commission had approved the project. There will be no expansion of the building footprint. Following discussion, a motion was made that the GCC authorize the work to proceed as presented and prepare a letter informing the Town of Gosnold that work could proceed with no further review. The vote to approve the motion was unanimous.

The GCC welcomed Chris Hart as a newly appointed member of the Commission

Received a request for Win Sanford and Wyatt Garfield seeking approval for replacement of moorings and chain with new pilings to secure their existing, permitted dock on Copicut Neck. The Commission responded by asking the applicant to file an RDA to be considered at a future meeting.

The GCC considered a new policy involving "General Provisions for Incidental Repairs" for licensed structures in the harbor. This item had been under consideration for a period of time. The Commission decided, following ample

discussions, that it was time to move forward. A motion to accept the "General Provisions for Incidental Repairs" as written was made. The vote on the motion to accept was unanimous. These regulations will be distributed and posted on the Town's website.

In reviewing open projects underway in Town, a discussion was held regarding some aspects of the Fuel Farm cleanup and the Water and Stormwater projects. It was agreed that issues relating to these projects would be considered when the proponents apply for Certificates of Compliance. There was general praise for the Town's contractors, Dig It Construction and Pawtucket Hot Mix Asphalt, and their responsiveness to issues as they arose.

A hearing was held to consider the RDA submitted by Win Sanford for dock repairs that has been presented to the GCC previously. The project would involve replacing nine 50' lengths of chain with 6 to 7 pilings. The proponent stated that eliminating the chain would reduce the wear and tear on the harbor bottom, and that the pilings would make the floating dock more stable. Following questions from Commission members and ensuing discussions, a motion was made to allow the project to move forward with no further GCC review for up to eight new pilings to replace the chain and moorings for the existing dock, as described in the Sanford RDA. All four members present voted in favor of the motion.

As part of the recently approved policy on "General Provisions for Incidental Repairs," the Commission will be reviewing the Chapter 91 licenses on file in Town Hall. Any request for work under the new policy will require that the applicant provide the license if it is not presently on file.

The Chair would again like to thank the members of the GCC for their willingness to serve in a capacity to help to preserve and protect the fragile environment encompassing the islands of the Town of Gosnold for us and for those who follow us in the future: Wyzie, for your calm and thoughtful demeanor; Chris, for bravely agreeing to join our noble cause; Leo, for your expertise involving regulatory and environmental issues; Lisa, for your island perspective in this instance and your willingness to do what needs to be done in a number of capacities in the Town.,

Thank you to the Selectboard for supporting the GCC in our efforts to implement the provisions of the Wetlands Protection Act that we are bound to uphold.

As a final note, I must report with substantial regret that Michael Parker made a decision to resign form the Commission in April. Michael's contributions to the

GCC were immense. The Orders of Condition that he wrote, and were approved by the Commission, were clearly crafted, effective documents that supported the efforts of the GCC to fulfill its mission in support of the Wetlands Protection Act (Chapter 131, Sec. 40). Thank you, Michael, for all your efforts and to Kate Parker, who so graciously attended our meetings and provided well-crafted minutes for us to consider. You will both be sorely missed.

### **CULTURAL COUNCIL**

The Town's Cultural Council receives federal (National Endowment for the Arts) and state (Massachusetts Cultural Council - MCC) pass through funds. The Council is tasked annually with considering a variety of arts and cultural experiences for the Cuttyhunk community and determining how to allocate those funds. In spite of the uncertainty and logistical challenges of the pandemic, the Cultural Council managed to provide a variety of programs for the community, including these annual favorites:

- The 6th Annual Cuttyhunk Plein Air Festival (the second virtual festival) that included forty-five registered artists. Artists participated on Cuttyhunk as well as off-island. The People's Choice award determined by 127 voters went for the second year in a row to Padanaram artist Robin Nunes, painting "Whale of a View." Robin has participated in past years both on and off island and is a talented watercolor artist that we are fortunate to have return year after year.
- The Annual July Avalon Family Lawn Concert, which featured Barry Gross and The Centre Streeters.
- The incredible creative Avalon Writing and Art Residency programs Tamalin Baumgarten organizes (partial funding).
- Nature & History Walks in July and August with Allie Thurston, which included informative sessions at the Cuttyhunk cemetery including the history of the land and tombstones.
- Plein Air Painting Workshops in July and August with Tammy Zimbone. The perennial favorite watercolor classes of this Island community continued with outdoor classes for a second season.

A summer highlight for all ages was a four day on-island sgriffito workshop led by porcelain artist and summer visitor, Tim Christensen. Sgraffito has been used for at least 6000 years to record information by using the universal language of art. The project included over 100 participants (ranging in age from 5-75 years old) etching a functional cup recording their perceptions of Cuttyhunk in whatever way they wanted: e.g. historical, social, environmental, or geographical terms. The porcelain cups are designed to last and be understood for thousands of years, and as a body, are a visual "self-portrait" of Cuttyhunk from the summer of 2021, as experienced by its inhabitants and visitors. Participants drew from their unique perspectives to express their own set of values, and together made an accessible, latitudinal, understandable, and community-held, record of the Island. The project included a public presentation on the project as well as the historical significance of sgraffito, an exhibit of Tim's own work, and daily sessions demonstrating the technique of sgraffito, and a final public showing of all finished products.

Additionally, The Council supported and benefitted from the first annual variety show hosted at the Wilder House at Four Corners. Mike Frazel organized an outdoor talent show complete with a stage, sound, and lighting. Actors, musicians, poets, dancers and more performed for close to two hours on a beautiful August evening. In true Cuttyhunk fashion all ages were encouraged and the youngest performer was five while the oldest was nearly eighty. People sat in lawn chairs, on blankets, and stood in the road as this show was not to be missed. It will for sure be a new summer event that islanders and visitors will look forward to

Finally, the Council helped organize a local New England Band, Chris James Trio, which played at the Fish Dock in late August and provided an evening of lively music that had people dancing in the parking area and many asking for them to return next summer. – And they plan to!

This includes compliance with a conflict of interest policy, and a required formal online application for all artists and 501 (c)3 organizations seeking funding. As a group we work closely with our Massachusetts Cultural Council liaison, Lisa Simmons. She is extremely helpful to the group and a great source of information and support to the Council.

Council Membership includes: Emily Anderson & Rebecca Garfield; Co-Chairs, Teri Bordenave, Cathy Ford, Diane Frothingham, and Tammy Zimbone as well as two new members who began this fall, Leyla Day & Mike Frazel. Sarah Smith, Town Treasurer continues to oversee the financial information and we are grateful for her work and expertise.

### FIRST AID & SAFETY (SUMMER 2022)

The Town Rescue Squad and visiting doctors continue to improve the service to the Town. We have 100% coverage of Drs. from June 15<sup>th</sup>-Sept 15<sup>th</sup> at the Infirmary.

The 911 system continues to be the main notification/response system for the Island. We appreciate the work of the Martha's Vineyard Communication. Center to be our central dispatcher Service.

Annual safety sheets are delivered to each house in June to remind Islanders and visitors of the routine for activating our response system.

With Covid 19 behind us, the island was calmer and had a good understanding of what to do, if someone did test positive. Glad to have this event behind us

We continue to use the local transportation systems to evacuate patients that need additional medical treatment off island. Thanks to JP Hunter, the Cuttyhunk Ferry, George Isabel, Wayne Perrier, and Seth Garfield for making their boats available for immediate transport to the mainland for additional medical help. We also have used the Boston Med Flight service and the USCG helicopter recently with excellent response times.

Numerous cases were handled in a variety of ways. Approximately 90 visits (and follow ups) to the infirmary were noted and an additional 12 were taken care of through the Rescue Squad. Residents of the Town make up about half of the calls, while visiting renters and yachtsman make up the rest.

New equipment and supplies continued to be purchased and donated during the year. I would like to thank all the patients and others who have donated to the Infirmary and the First Aid fund. We all benefit from this service by continued training and updated equipment. **DONATIONS ARE ALWAYS ACCEPTED AND APPRECIATED.** 

A special thanks to the Avalon family and Tamalin Baumgarten and the Avalon crew for making the rooms available for the doctors and for making their stay enjoyable. Also, to Dr. and Mrs. DiMare for their coordination of visiting doctors and enthusiasm for this service. They solve many problems quietly behind the scenes. The doctors' golf cart continues to be used and serviced each year.

The First Aid and Safety van continues to be used as the primary supply center and first aid station.

The members of the Rescue Squad would like to thank you for your continued support in the community. We work hard to keep Cuttyhunk a safer place for all. We appreciate you doing your part to make Cuttyhunk a healthy and safe place to live.

We welcome anyone who would like to join the department and rescue squad.

Training for the members and maintenance of the equipment continues and training in 2022 will be combining and cross training members in fire response, first aid and in emergency managements. We want to include new members to the community and increase coverage on island during the year.

We are planning to have a joint burn on BBC land in the spring of 2023. This will help reduce fuel loading and also show the island that our CWPP plan that we developed in 2017 will start to be implemented. This can be a training session for the department. We also are working with the BBC to have additional equipment to help in brush fires.

Again, it is planned in the summer 2023 to continue to train the junior volunteer fire department. Many of the current citizens of the Town were members back in the '80s. This will increase the education and response in the Town during the busy summer weeks.

Please take the time as you open up your homes for the summer season to inspect and/or replace your fire extinguishers. Also please check any lamp cords that may be dried out or mouse eaten and replace as needed. This helps reduce risk and improve safety in your house.

Thank you for your help in making the Island a safer community.

### **HARBOR COMMITTEE**

The Harbor Management Committee is an independently elected body consisting of 7 volunteer members which has the responsibility of overseeing and managing the use of the sheltered waters of the Town, pursuant to a 1990 bylaw. In addition, the Selectboard has delegated all management of the operations of Cuttyhunk Harbor, including the moorings, marina, and the docks, including the Fish Dock, Ferry Dock, and Fuel Dock, to the Committee.

Our committee members and our harbor staff have worked closely together to achieve the goals that we set over 12 years ago. We have been focused on improving the marina operation, enhancing the first impressions of visitors to Cuttyhunk, and most importantly increasing our revenues to help offset the Town's expenses. Total receipts for the 2022 season were \$610,000, which represents over 45% of the Town's annual budget.

Over the past two years the Committee has:

- Supported the development of a new fuel farm and upgraded fuel dock equipment to make sure that resident and visiting boaters have access to fuel.
- Instituted a \$5/night Environmental Fee for all overnight visitors at the marina and on the public and private rental moorings to offset rising solid waste management costs.
- Rewired the power posts at the Marina.
- Revised Fish Shack and slip occupancy criteria.
- Revised regulations for vendors in the Town Dock area.
- Contracted for WiFi service to cover the entire mooring field.
- Continued the process of maintaining the rental mooring pennants.

We appreciate the team effort from our committee members and the harbor staff that includes Harbormaster/Wharfinger George Isabel, Mooring Collector/Asst. Harbormaster Dale Lynch, Angus Garfield, and Peggy Lovell. In addition, our residents and Island workers on the dock have been consistently helpful and friendly to our visitors. All of this positive attitude contributes to the annual reviews we receive on social media, and the marina continues to win the "Boaters Choice Award" from Marinas.com, and accolades from Dockwa users. Please join me in thanking the entire harbor staff for their efforts.

Ongoing projects for the Harbor Committee include planning for a replacement for the Public Toilets building, and continuing to study the reconfiguration of the marina with floating docks, with Susan Nilson and her staff at Foth Infrastructure & Environment. Please contact a Committee member if you have

questions, or suggestions for improving our harbor operations. You are welcome to join any of our public meetings in person or via Zoom teleconference.

### **HIGHWAY**

WOW, what a summer. As we know, we all had to endure dust, noise, mud, traffic, and more for the whole summer. Thanks for all being safe, aware, and staying positive. The final resurfacing was complete in October and we are working on a few issues to finalize the entire project.

The Town received grants to improve drainage on Tower Hill and Broadway. This work started in May of 2022, as well as the replacement of water lines in Town. This work will last for decades.

The roads of the island continue to be cleared and mowed during the summer. Efforts are made to clear the visibility of the corners to reduce accidents, sand is removed to reduce skids, and during the winter the roads are plowed and salted accordingly. We did not have to plow for the winter for 22/23, very warm and enjoyable. The department continues to use about 20% of the space of the USCG boathouse. This building is used by many departments and will also be redesigned as a visitors' center for the summer of 2023.

Yearly, the road drains of the town are cleaned out so they operate correctly. During the final paving we had a high tech vac truck come to the island and clean all drains.

All suggestions are welcome, and we look forward to keeping the roads safe for all.

As always, thank you for driving slowly and carefully, especially in the summer. It is clear that there are more carts on the road, as well as pedestrians.

REPORT OF THE SUPERINTENDENT OF SCHOOLS January through December 2022

#### TO THE CITIZENS OF THE TOWN OF GOSNOLD.

It is a great honor to serve your school district as Superintendent of Schools. The school year 2021-2022 was one of great challenges and opportunities for the school department. In my annual report for January – December 2021, I reported to you about the impact of the Covid pandemic on the first half of the school year September through December, 2021. In this report, I will provide you with information about the second half of school year January through June 2022 and summer and fall of 2022. In the schoolhouse from January through June of 2022, six children who represented four families attended Cuttyhunk Elementary School. We also had homeschooled children whose programs were developed in conjunction with the families and approved by the superintendent of schools. The children who attended school in the schoolhouse were engaged in a face-to-face educational experience. This was somewhat unique as many schools were still providing a hybrid model to the students because of the lingering pandemic.

During the 2021-2022 school year, Michelle Carvalho held the position of teacher/principal. Additional staffing included an art position, music and physical education instruction. These programs added value to the educational experiences of our children. The School Committee was pleased to contract with Chris Bergen to house our Teacher/Principal for school year 2021-2022. Thank you to Mr. Bergen for providing a pleasant residence for our staff.

For the 2021-2022 school year, enrollment also included one student on Naushon Island attending the Falmouth Public Schools. The student traveled everyday via the MV Cormorant ferry to Woods Hole where she was met there by the Falmouth Public Schools bus and transported to her school. At the end of the school year in June of 2022, the student on Naushon Island withdrew from the public school system and enrolled in a private education program.

ESSER II funds were expended during this period of time. This is a federal entitlement grant and helped us to address learning loss as a result of COVID. These funds were used to provide additional assistance and enrichment in the classroom. The next phase of funding through this federal grant program is ESSER III funds. We applied for these funds and our grant was approved. We

are in the process of evaluating the school building needs as they relate to HVAC and water mitigation in the basement. We have hired an engineering firm to conduct that assessment. ESSER III funds will be used to support this project.

During the spring of 2022, we began planning for the School Department's Summer Art Camp on Cuttyhunk. The director of the 2022 program was Michelle Carvalho. The program provided the option of either one or two weeks of island experiences for children who visited Cuttyhunk during the summer months. The program was held at the schoolhouse. The Art Camp began on July 25, 2022 and ended August 5, 2022 Based on enrollment and feedback from the children and from their families, the program again was a tremendous success.

In the fall of 2022, the school department started to plan for the 150<sup>th</sup> birthday of the schoolhouse in 2023. Repairs to the building and maintenance on the grounds are being discussed in anticipation of a celebration recognizing this milestone in the summer of 2023.

The members of the school committee include the following: Chairperson, Dorothy Garfield, Secretary, Judith Archer and members Renata Davidson and Paula DiMare. Your school committee provides me with the support and guidance that I need to manage the school budget and set the policy direction for your public school program. I thank them for their dedicated service. I also want to take this opportunity to thank the Gosnold Board of Selectmen, the staff, the parents, community members, and the numerous volunteers. Additionally, I want to thank Joan Reed for her service as Business/Executive Secretary and Lisa Wright, Town Clerk and Sarah Smith, Town Treasurer for their ongoing assistance and support. A special thank you to teacher/principal school year 2021-2022, Michelle Carvalho, for her dedicated service to the Town of Gosnold.

This report serves as a snapshot into the many projects, specific activities and events of the Gosnold Public Schools for the time period January through December 2022. Thank you to the community of Gosnold for your active and generous support.

### OFFICE OF THE SELECTMEN

INFRASTRUCTURE PROJECT UPDATE: In the last year Gosnold has undertaken and completed the largest projects in its history, the Tower Hill Road Project, and the replacement of the Water Wells and 1.5 miles of water piping. Additional benefits include new fire hydrants and paved roadways for most of the island. We have begun the installation of the new town owned fuel farm after 3 years without marine fuel. And while these projects overshadowed the other operations on the island that make it possible to live and work here, everyone worked together in new ways to assist in all it took to house, work, and support the effort. The dustbowl provided by Mother Nature in the summer of 2022 tested all those who lived along the roadways who suffered daily with yellow clouds of dirt imprisoning them in their houses during a summer when virtually no rain was to be had.

The Selectmen have worked hard to search out grant money to fund the scale of these projects, and, without the significant contributions from state and federal sources, these projects would not have been possible. The cultivation and site visits from various agency and government leaders has been rewarding, as we do not fit many norms. From the time applications were submitted to the completion of the work nearly four years have passed. The bids for all these projects came in higher than expected, and, as we turned to our legislators and state agencies, additional funding was given in the final hour, without which the projects would not have gone forward. Each grant application process includes a written case for funding, sound financials, and required engineering studies. Added to this is the bid process, the acceptance of legal contracts and ConCom approvals before a shovel even goes in the ground.

Given the scale of these projects it is important to thank all the people and agencies involved in the funding sources for these projects: Karyn Polito, Lieutenant Governor; Beth Card, Executive Office of Energy and Environmental Affairs; Rebecca Strohm, Branch Chief, USDA; Jennifer Lerch, USDA Director of Business and Community Affairs; Steven Chrabascz, USDA State Engineer; Ellen Cebula, Seaport Economic Council; Stephen McKenna and Patricia Bowle, Coastal Zone Management; Laurie Stevens and Jim Starbard, RCAP Solutions; Environmental Partners, Dig It Construction, Susan Nilson, FOTH Engineering; Dave Walsh, Pawtucket Hot Mix; Manny Capriotti, Capriotti Builders and Masonry.

These two infrastructure projects needed to be done in parallel and we thank the fearless Leo Roy for his oversight in the bid process and getting everyone to the mobilization phase. Dale Lynch was involved in the logistics of the Water Project from day one. The island took on long term debt for the Well and Water Project at a favorable rate of 2.625% provided by USDA. Along with town matches, major funding for these and other projects has been provided by state and federal grants.

Our two major contractors, Dig It and Pawtucket Hot Mix, truly enjoyed this project. They contributed in ways above and beyond the parameters of their contracts, helping residents with special requests, and trying to stay ahead of the dirt and dust. Of course, there were surprises along the way and some interesting situations. The Fishing Club thankfully offered their property for the workers' temporary trailers. We all have our stories about what went on, but we could not have asked for a more responsive crew. The paving truck had to remove side panels to squeak by the walls on Tower Road to pave Tower Hill. A huge thanks to Dale Lynch, and Wayne Perrier who had many extra hours added to their normal responsibilities to respond to every little issue as the work was done. If you were on island, you saw it!

FUEL FARM: The fuel farm should be nearly complete by the time you read this report. Two 6000 gallon tanks, one for gasoline and one for diesel will be installed with two dispensing stations, one on the dock and one by the tank yard for vehicles. A new shed for the contracted operators will be installed on the fuel dock. It has been three years since the island has had fuel, another welcome improvement. A new public toilet at the ferry dock will be a welcome addition for our visitors and beach goers.

Additional infrastructure projects will include the future needs of the islands in the face of climate change. On the water side, the marina docks and floats will need to be raised, and the channel and beach erosion at Barges and Church's beach needs to be addressed. On the land side, the power plant and power distribution lines need upgrades, and the solid waste yard will be reconfigured. Lastly, we hired CCG, an internet consulting firm, to investigate the possible viability of an island wide internet that serves the residents and the marina, a priority of the residents.

FINANCE: following the requirements of DOR the Electric Light Department is now an enterprise-like fund, along with the Water Department. This means each department must support itself. We will undertake a rate study for Electric Light which includes the solar farm to determine how to adjust rates if needed. We have contracted with a new utility billing service so that you can view your own activity and pay bills on line. We have engaged a new auditing firm. We owe our Treasurer, Sarah Smith a huge thanks for continuing to work on all these improvements to our systems, and for the extra work in transitioning to these systems.

REVALUATION: As required by the state a revaluation of all the properties for real estate tax purposes was completed in the last year. This included giving the assessor the ability to update records on the web, remeasuring and updating property records, and engaging a new assessor for the town following the retirement of Kresenia Lombard who served us well for many years. This was a lengthy process but now gives us updated records

BUZZARDS BAY COALITION(BBC): Completed signage for their properties, installed new split rail fences, enhanced the parking lot with clamshells, installed bike racks, and provided handcarts for Barges Beach users. Trails to the top of Bayberry and Tower Hill are improved. Most important the Conservation Restriction (CR) for some 200 acres of land from the Spauldings will allow for Public Access linking of Tower Hill, Bayberry Hill and the bunker trails.

CHANNEL DREDGING: Our repeated need to keep the channel open and dredged has been funded again by the Army Corps of Engineers, thanks to the work of Gail Blout to maintain contact. The town has an award of \$1.8 million to dredge when the Corps has time to schedule it as the Channel becomes more twisted and overwash from Barges occurs more frequently.

SCHOOL: The School has its own report to give as it celebrates its 150 year anniversary. Our school still remains closed as no students are on island, but it is being used by the STEAM program, under Michelle Carvahlo's guidance this spring. The Island Institute in Maine is bringing their island wide school program to the island this spring. STEAM is officially a 501c3 with three board members, Sandy Parker, Charles Field and Ann Conway, and is funded by private donations and program attendance.

POLICE: Massachusetts Police requires all retired police to fully maintain all certificates and keep up with training in order to work in retirement positions, which has made it more difficult to find a candidate. We expect to hire for the summer months for public safety as the summer season is so busy.

SOLID WASTE. The regulatory requirements for disposal of solid waste continues to add to the overall cost of our operation. Both barge costs and tipping fees have climbed significantly. Plans are underway to upgrade the solid waste yard in 2024 after the completion and disruption of the installation of the new fuel farm. Efforts to be greener and more efficient island wide are underway and need to be embraced. Even though we are a small community this department remains a large part of our budget and for the first time we have added an annual fee in addition to our bag fees for both residents and businesses to offset only some of the additional costs, which may change again as needed.

EMERGENCY SERVICES: We are grateful to the many responses led by Fire Chief and EMT Seth Garfield and team for the emergencies they deal with every summer at any time of day. This includes the effort by Paula and Seymour DiMare who continue to provide a doctor of the week at Avalon for the busy summer months. This has become an important and reliable resource for residents and visitors alike.

ENVIRONMENT AND CLIMATE CHANGE: The island has nearly completed the process of becoming a Green Community which the Mass Department of Energy Resources supports. We continue to participate with the Martha's Vineyard Commission in the Municipal Preparedness Vulnerability Program for future environmental threats the islands may endure.

TOWN HALL: We all go to Town Hall for every kind of question we don't know the answer to and services we need. That means we go to Lisa Wright who manages the front line year round. We owe her a huge thanks for all the departments she monitors and all the hats she wears Sarah Smith, our treasurer, has responded efficiently to all the suggestions from DOR for best practices, and has taken on the many new tasks required for our projects as well as the ever increasing regulatory filings. The Tower Hill and Water projects require separate audits over and above the regular business of the town as they are completed.

APPRECIATION: Each year we look back at all the contributors that make it possible for so many to enjoy the island, and who keep it functioning during the dark and stormy days of winter. We are perpetually hopeful the year round population will slowly increase and that a new generation will come together to operate the systems that support us all. We cannot look back on this last year without once again thanking Dale Lynch, Wayne Perrier, Sarah Smith, Lisa Wright, Asa Lombard, Seth Garfield, Captain Jono Billings and his crew, John Paul Hunter and Seahorse, and Paula DiMare and the Cuttyhunk Telegraph, and the many volunteers too numerous to name. All these individuals wear many hats, asked for or not, and contribute to the livability and accessibility of Gosnold. Buzzards Bay Coalition, and Audubon have opened up more trails for the public. In the last year the work of ConCom has been demanding, and the Harbor Committee has worked hard to complete the fuel farm project. There is no question that the projects of the past year demanded more of all these individuals, as well as the residents and we hope the pain can be forgotten with the results you can now see. The Selectboard has worked collaboratively to bring these important projects to conclusion, with more to come to secure the future of important island needs.

# SOLID WASTE

We have had a busy year for the Solid Waste Department. The Town requires that we use the green GOSNOLD trash bags for household trash and curbside pick-up. Disposal of larger items such as scrap metals, wood, mattresses, chairs, etc., will be picked up by contacting the Solid Waste Manager or one of the summer Solid Waste staff

Carpentry, building, and home improvement projects which create construction debris can be disposed of by making arrangements for a dumpster to be dropped off at your location.

I would like to remind all Islanders that the trash bins which are located in the parking lot at the Town Marina are for marina and boaters' trash only. Please do not put household trash in these containers.

The large dumpsters that are located inside the fenced areas at the Town Ferry Dock are not set up for public drop-off. Please do not leave items and trash outside the fenced area. Items being left here are increasing and becoming a problem.

During the summer, green GOSNOLD trash bags can be purchased at the Town Hall and at the Wharf Shack. We also carry them in the Town Truck and at the Island Market. Thank you for your cooperation in keeping Gosnold clean.

# WATER DEPARTMENT

The Town of Gosnold Water Department continues to provide the best quality drinking water to our residents and visiting guests. Under the guidelines of the EPA Clean Water Act and Mass. DEP Drinking Water Quality Programs, we monitor and sample our drinking water both monthly and quarterly for a myriad of contaminants, which thankfully are absent from our drinking water supply. We, in turn, provide the results of our sampling to the Mass. DEP for performance, safety, compliance and record keeping.

Each year the Gosnold Water Department assembles a Consumer Confidence Report, a copy of which is available for public review located at the Town Hall, Library, or by contacting the Water Department Manager @ (508) 990-7408

Water Meters are read bi-annually. (May and November) Questions regarding meter reads or billing can be directed to either the Town Clerk or Water Manager. We will make every effort to answer your questions or resolve issues connected with your water bill in a prompt manner. Bills can be paid on-line in the near future.

The town regulations that protect our aquifer and drinking water supply mandate that the wellfield/aquifer area, pumping station and water storage tanks are Off Limits to the public. Trespass or vandalism is taken very seriously and is considered a felony offence.

As this is our sole source of drinking water for the Island and we ask for your help in protecting it by limiting the unnecessary use of pesticides/insecticides whenever possible. Additionally, please be sure that any business or household hazardous waste is disposed of in an environmentally responsible manner off Island.

Water conservation measures may be implemented during peak summer months based on prolonged drought periods. If this were to happen, the public will be adequately notified and we would ask for your cooperation in conserving water during these periods.

With the completion of the New Wellfield and Waterline Replacement behind us this year we will implementing the requirement of the use of hose bib vacuum breakers on all outside silcocks (faucets). Our goal is to equip all homes, businesses, Fish Dock, Marina and Wharf with hose bib vacuum breakers. Two (2) units per household will be supplied and installed at no cost. An explanatory public service sheet will also be provided to explain what vacuum breakers are and why they are important in a community water system.

Finally, a Notice to Contractors and other Dept. Heads. No attachments shall be made to any fire hydrant within the Town of Gosnold in connection with any temporary water supply, watering of lawns, flushing storm drains or hydroseeding activity without the use of a reverse back flow protection device (RPZ).
