SELECTBOARD:

A motion was made to accept the minutes of January 9, 2023. Duly seconded. So moved. Unanimous vote.

WATER:

The first repayment of the water project loan will be in November 2023.

ASSESSOR:

CEMETERY:

ELECTRIC:

LIBRARY:

Gail and Lisa have been working with Samuel Harps who is a playwright and wrote a play about Paul Cuffe who was born on Cuttyhunk in 1759. Samuel hopes to perform the play on Cuttyhunk this summer. This would be a fund raiser for the library.

STEAM:

Michelle Carvalho reported that STEAM now has official nonprofit status and has several day and overnight programs scheduled this spring. Michelle has fund raising ideas for the program. STEAM will be hosting the Island Institute TLC Learning Collaborative in the middle of May on Cuttyhunk.

CLIMATE ACTION NETWORK:

Jonny Winet reported that he will meet with Mark Rasmussen of the Buzzards Bay Coalition on Monday.

FUEL FARM:

Michael Milanoski reported that the fuel project will begin mobilization on March 12 and should be finished by the end of May. The new fuel building needs to be completed by mid-April as it is an integral part of the electrical installation. The new building (16 X 24) will be stick built; there is some concern about the size of the building. Proposals for the concessionaire are due March 15.

INTERNET:

The Selectboard is waiting to hear back from Karen Walega on the proposal for waste water at the fish dock shacks.

GREEN COMMUNITY:

We need additional documentation, including a vehicle inventory.
